WRIT OF ARREST

REPUBLIC OF LIBERIA, TO CAPTAIN LARRY GORNUIYOR MAGISTRATE POLICE OR HIS DEPUTY
GREETINGS:

You are hereby commanded to ARREST the living body (ies) of Jessica D. Osterhout to
be identified
Defendant(s) and forthwith bring her before the Monrovia City Court, Temple of
Justice Building, Montserrado County to answer the Charge of Criminal Coercion,

Based upon the oath and complaint of the Republic of Liberia by and thru
Victor Reeves and Augustine Wolo, private
Prosecutor (trix) in which it is substantially alleged as follows to wit:

That during the period of January 23, 2017, the within named defendant who now
in the City of Monrovia and currently lodging at a local Hotel in Monrovia,
purposely and intentionally did accuse the private prosecutors, who also are
officers of the Liberia Immigration Service of exploiting, harassing and extorting
money from her at the Robert International Airport, which said accusation the
defendant has placed on FaceBok tarnishing the good reputation of the said private
prosecutors with the intent to subject the said private prosecutors to hatred and
ridicule.

The alleged act of the defendant being unlawful, wicked, illegal and intentional is
in violation of section 14.27 of the New Penal Law of Liberia there and then crime herein
defendant did do and commit.

Hence, this writ of arrest.

SUCH CASES MADE AND PROVEN AGAINST THE PEACE AND DIGNITY FOR THIS
